PCSO Aled Hughes had advised that he was planning to attend the meeting. Aled had attended the Remembrance Service at St. Barts.

23/158 FLINTSHIRE COUNTY COUNCIL ISSUES.

- a) Ferry Lane Footbridge
- i) Project to improve the footbridge to reduce the noise nuisance

There was no report.

ii) A frame barrier amendment proposals

The County Councillor advised the A frame proposals will be considered by the County's Scrutiny Committee.

b) Dandy's Top Soil – Sealand Road

County Councillor Chris Jones advised on 11th December 2023 that she has requested Matthew Linford – Planning Enforcement Officer to visit the site to check if all activities have planning permission or certificates of lawfulness.

RESOLVED – that the report be noted.

c) Sealand Ditches

Neil Parry advised on 8th December 2023 that he has spoken with Stuart Banks about the watercourse adjacent to Cottage Garage and that he will be meeting him on site week beginning 11th December 2023.

Neil has now inspected the watercourse to the rear of Deeside Crescent. This watercourse does need to be desilted and Neil will be e-mailing the Riparian Owner to ask them to undertake this work. Neil will advise when this work has hopefully been undertaken.

Saughall Parish Council (SPC) have asked about a possible joint meeting regarding flooding on Seahill Road. SPC have been advised that Council has been informed that all the drainage ditches in this area of Sealand have recently been checked and cleaned. SPC will try to find out from the land owners on their side of the border whether the ditches have also been checked and cleaned. SPC have advised that there are no ditches on the England side.

The Clerk asked Neil Parry on 5th December 2023 whether he is aware of any drainage ditches that are across the border in England and are impacting on the flooding issues in this area and whether he would he agree that the flooding issue on Seahill Road is caused by the drainage ditches not being able to drain away excess rainfall. Re Seahill Road it is assumed that the surface water drains to the above ditches. SPC have been advised of this.

RESOLVED – that the report be noted.

d) Concern about condition of side access – Spar Shop, Welsh Road

Glyn Jones has advised that the report of the site meeting held on Thursday 2nd November 2023 will shortly be provided.

RESOLVED – that the report be noted.

e) Damaged fencing – Cycle Bridge – A494

Traffic Wales advised on 19th September 2023 that they consider Council's enquiry to be operational in nature, requiring a detailed response. They have forwarded the enquiry to North and Mid Wales Trunk Road Agent.

RESOLVED – that Wayne Jones and Ian Bushell be advised that repairs works have still not been carried out.

f) Sealand Road – A548 – Extend Street Lighting

Darell Jones asked on 27th September 2023 whether Council requests for a lighting assessment to be undertaken in accordance with the BS and FCC policy. This was confirmed to Darell on the same date.

g) River Dee Embankment – Coastal Path and Cycleway – Bluebridge to the Railway Bridge

Mike Taylor has previously advised that the repair cost is £200.00 per bench. Source for the funding is being investigated. Council has agreed that the seat formerly situated between the two road bridges should replace one of the existing 4 seats as above. Wayne has advised that he is waiting on Mike re-funding.

23/160 SECTION 137 – LOCAL GOVERNMENT ACT 1972 – PAYMENT OF GRANTS

The appropriate sum for the S137 Expenditure Limit for the purpose of Section137 (4) (a) of the Local Government Act 1972 for the calculation of the Free Resource Base is based on the local population taken from the current electoral role. The Welsh Government have advised that the Section 137 Expenditure Limit for 2023/24 is £9.93 per elector. The electoral role from Flintshire County Council was 2538 at December 2022. So, per elector produces a total of £25,202.34. Allocated spend in 2023/24 is Section 137 grants of £4,000 and for school milk £0.00. The Section 137 Expenditure Limit for 2024/25 is £10.81 per elector. The electoral role from Flintshire County Council at September 2023 was 2565. So, per elector produces a total of £27,727.65. Spend in 2023/24 so far is £1,250.00 - Sealand Primary School £1,000 and for the Earl Haig Poppy Appeal £250.00.

The Acting Headteacher would very much like to apply for an additional community grant. We are looking to raise funds to replace our climbing frame with some new play equipment for the children.

A grant request has also been received from St. Bartholomew's Church

23/167 WELSH ROAD SKATE FACILTY

Richard Roberts – AURA - Play Design Officer advised that the skate ramps were removed on 24th November 2023 and that he has not received any phone calls or emails from the public in relation to their removal.

Richard advised that the quote for a single ramp dated 27th November is for £19,615. The Clerk advised that £3,900 remains in budget for 2023/24 and could be rolled over to 2024/25 increasing the matched fund allocation to £8,900. Richard advised at best, and pending the financial settlement Aura receive from the County Council from April 2024, Aura will only be able to match the £8,900 meaning the total funding available will be £17,800. This leaves a shortfall of £1,815. Without additional funding from the Community Council then Aura will be unable to proceed. Subject to the variables highlighted above, Richard's advice would be to factor in 10% over the next year, in addition to the current shortfall of £1,815. So, £11,000 in total is needed by Council to fund the new provision in 2024/25.

RESOLVED – that the report be noted.

23/168 PLAY SCHEMES - 2024

At the November 2023 Council resolved to fund both sites in 2024 for 6 weeks and to enter a 3 – year commitment noting that Council can amend its commitments at any time regarding future years. Darren Morris – Lead Officer for Play Development advised on 24th November 2023 that marketing will be done digitally and these will be shared with you to promote the schemes, it will be sent to all schools and used on FCC social media. They are also looking at a short film to promote the schemes that schools can show as part of their assemblies, but this is dependent on agreements and consent.

23/173 FINANCIAL REPORT – 2023/24 and 2024/25

The Clerk advised on the Financial Report as circulated: -

- a) that a precept is an order to the charging authority Flintshire County Council to pay a requested sum to the precept authority – Sealand Community Council and that the schedule of payment from Flintshire County Council will be 3 equal instalments – on the last working days of April, August and December.
- b) the appropriate sum for the S137 Expenditure Limit for the purpose of Section137 (4) (a) of the Local Government Act 1972 for the calculation of the Free Resource Base is based on the local population taken from the current electoral role. Welsh Government have advised that the Section 137 Expenditure Limit for 2024/25 is £10.81 per elector. The electoral role from Flintshire County Council at September 2023 was 2565. So, per elector produces a total of £27,727.65. Allocated spend for 2023/24 for Section 137 grants is £4,000. Section 137 payments so far in the 2023/24 financial year are for grant payments to the Sealand Primary School £1,000 and for the Earl Haig Poppy Appeal for £250.00.
- c) the Clerk is contracted for a working week of 16 hours. Payment is net with the Council deducting income tax at 40% on the full income and making payment to the HMRC. The Council also pays the employers National Insurance contribution to HMRC. Payroll being undertaken by Wainwrights Accountants.
- d) refer to Minute 21/80 meeting 19th July 2021 RESOLVED that it be agreed that the Clerk should move to scale point 24 with effect from 1st April 2022 and then point 25 at 1st April 2023 and point 26 at 1st April 2024. Council also agreed under minute 21/80 that that with effect from 1st April 2022 that the home allowance payment is £312. Noting that the internal auditor advised on 22nd April 2021 that this amount is non-taxable.

The NALC pay award 2023/24 has been advised on by the LGA via One Voice Wales and to be implemented from 1st April 2023. Copies of the pay award details and salary scales were circulated to members of Council on 7th November 2023.

Based on contracted 16 hours worked the salary for 2024/25 on scale point 26 £34,834 will be

- £15,063. Plus, the home working allowance of £312 = £15,375. All the above was noted by Council at its meeting on 20th November 2023 minute ref 23/145.
- e) that IT expenses will be reimbursed by the Council.
- f) non-IT expenses incurred in carrying out his duties are also reimbursed. The expenditure being incurred on behalf of the Council as part of its administration and running cost, i.e. stamps and travelling expenses. NJC rate for Casual Users / HMRC approved mileage rate being paid for car mileage within Sealand and as required mileage to venues outside Sealand £0.45p per mile.
- g) the estimated income for the current 2023/24 financial year is £68,130 and estimated expenditure is £60,121. The opening balance at 1 April 2023 was £41,105. The estimated opening balance at 1 April 2024 is £49,114 assuming all planned expenditure takes place which may not be the case.
- h) the precept for the 2023/24 financial year is £62,000

23/174 PRECEPT 2024/25

The Clerk advised that the Council has an indicated estimated expenditure of £71,975 for the 2024/25 financial year. Estimated income excluding precept for the 2024/25 financial year is £2,500 – made up of HMRC VAT refund and bank interest. Estimated opening balance at 1st April 2024 is £49,114.

The Clerk advised that the County Council require the completion of a precept mandate form to be signed by the Chairman and Clerk.

Current year's precept – 2023/24 - £62,000 Current Tax Base of equivalent Band D properties is £1,458.01 The current Band D charge is £42.52

After much debate and consideration it was decided to agree on a Precept of £64,000

The precept for 2024/25 - £64,000

Tax Base for 2024/25 of equivalent band D properties is £1554.24

The band D charge for 2024/25 will be £41.18

The decrease in the band D charge amount is £1.34

The percentage decrease in the 2024/25 Band D charge compared to the 2023/24 B and D charge is $3.15\,\%$

RESOLVED: - that -

- i) the precept for the 2024/25 financial year be agreed at £64,000.
- ii) Clerk be thanked for his usual excellent and informative and very clear financial report.

23/175 **COUNCIL RESERVES – 2024/25**

The Council's policy on Financial Reserves recommends an amount to be held in reserves for contingency purposes should be proportionately 6-9 months of gross expenditure – estimated expenditure for 2024/25 is £71,975 – 6 months is equivalent to £35,988

RESOLVED – that of the estimated carry forward of £49,114 at 1st April 2024 an amount of £25,000 will be held as a Contingency Reserve to assist cash flow in the event of unforeseen occurrences. The remaining funds being required to cover council expenditure until the first precept payment is made by Flintshire County Council during the 2024/25 financial year. The Council's Policy on Reserves will be amended accordingly.
