1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £1,900 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Sealand Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Electors' rights to inspect the accounts

I draw attention to the Council's omission of a response to assertion 4 in the Annual Governance Statement.

The Council is required by law to make its accounts available for 20 working days prior to a date set by the Auditor General. This was 15 September 2024.

I have been unable to locate a copy of the notice of inspection that the Council is required to publish although the inspection period is referred to in the Council's minutes.

We recommend that the Council publishes the audit notice on its website on the relevant page for the accounts and audit. See also below.

Website

The Council's website has a specific page called 'Council Finances and Audits'. In my opinion, this page is confusing to the user.

Page 1 of 2 - Auditor General's report and audit opinion - please contact us in Welsh or English / cysylltwch â ni'n Gymraeg neu'n Saesneg.

Many of the document titles bear little to no resemblance to the actual purpose of the document. Furthermore, documents that should be published are not listed e.g. audited annual accounts and the Auditor General's report, notices of completion of the audit.

We recommend that the Council reviews its use of this page and ensures that documents are clearly and accurately labelled and that all relevant documents are published.

There are no further matters I wish to draw to the Council's attention.
